in and to said invention as described in the above application for design patent, for the territory of the United States and its possessions and territories and all foreign countries, and

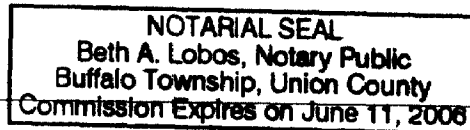



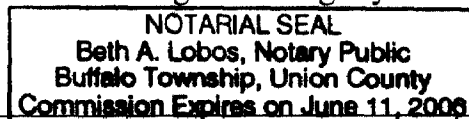
