

And I hereby authorize and request the Commissioner of Patents and Trademarks or other proper governmental authority to issue all Letters Patent or other patent rights for the said invention resulting therefrom to the Company, its successors and assigns, in accordance with this assignment, as assignee of the entire right, title and interest therein and thereto, and covenant that I have full right so to do.

And for the considerations aforesaid, I agree that I will communicate to the Company, or its representatives, any facts known to me respecting the said invention, whenever requested, and will testify in any legal proceeding, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid the Company, its successors, assigns and nominees, to obtain and enforce proper patent protection for the said invention in all countries, or to perfect or defend its or their title in the premises.
