## ASSIGNMENT

WAGSTAFF, INC., a corporation of the State of Washington having a place of business at North 3910 Flora Road, Spokane, Washington 99037, filed a first Application for Letters Patent Of The United States on July 10, 1997 in the name of Michael K. Anderson as sole inventor of all inventions disclosed in said Application. The first Application was entitled A SYSTEM FOR PROVIDING CONSISTENT FLOW THROUGH MULTIPLE PERMEABLE PERIMETER WALLS IN A CASTING MOLD and was given Serial No. 08/891,019 by the U.S. Patent and Trademark Office. On July 20, 2000 a second Application was filed in the U.S. Patent and Trademark Office by WAGSTAFF, INC., under the same title and in the name of Michael K. Anderson as a continuation of Application Serial No. 08/891,019 (abandoned). The second Application was given Serial No. 09/620,110 by the U.S. Patent and Trademark Office.

By a duly executed instrument dated July 10, 1997, and for sufficient, good and valuable consideration, the receipt of which was acknowledged by him, Michael K. Anderson sold, assigned and transferred to WAGSTAFF, INC., his entire right, title to and interest in said first Application, said inventions, and all other Applications on said inventions, U.S. or foreign, including the right to apply for Letters Patent on said inventions in foreign countries in his name or in the name of WAGSTAFF, INC. The instrument was duly recorded in the U.S. Patent and Trademark Office on July 10, 1997 at reel 8689, frame 0690.

WAGSTAFF, INC. subsequently filed with priority from the first U.S. Application, a corresponding PCT Application, namely corresponding national phase applications are listed on the Appendix attached to and made a part hereof.



All inventions and all Applications and patents on the same are to be held and enjoyed by ALCAN INTERNATIONAL LIMITED as entirely as the same would have been held and enjoyed by WAGSTAFF, INC. had this sale, assignment and transfer not been made, and WAGSTAFF, INC. agrees and promises to execute all instruments and render all such assistance as ALCAN INTERNATIONAL LIMITED may request to confirm in ALCAN INTERNATIONAL LIMITED legal title to all of said inventions and all Applications and patents thereon and to enforce all patents on said inventions, all without charge to ALCAN INTERNATIONAL LIMITED but at no expense to WAGSTAFF, INC.

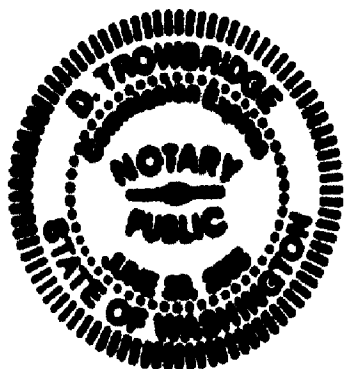
