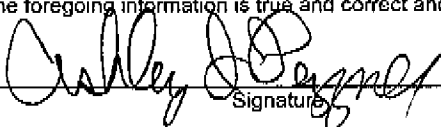

The company (as the controlled company) entered into a control and diversion of profits agreement on December 18, 2001 with Basell Germany Holdings GmbH, having its registered office in Wesseling (the controlling company, Brühl District Court HR B 3241). The shareholders' meeting of December 19, 2001 consented to this agreement. Reference is made to the documents submitted for the content of this agreement and of the consent declarations. By a resolution of January 31, 2002, the shareholders' meeting moved the registered office from Kehl to Wesseling and amended Article 1 (1.2) of the articles of association accordingly. The company has two or more directors who are appointed and whose appointments are terminated by the supervisory board. The company is represented by two directors jointly or by one director jointly with one authorized signatory. It is possible for power of individual representation and for exemption from the restrictions of Section 181 of the German Civil Code to be granted.
