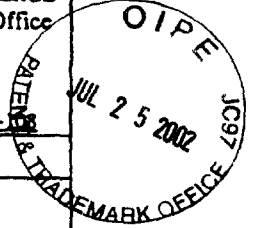

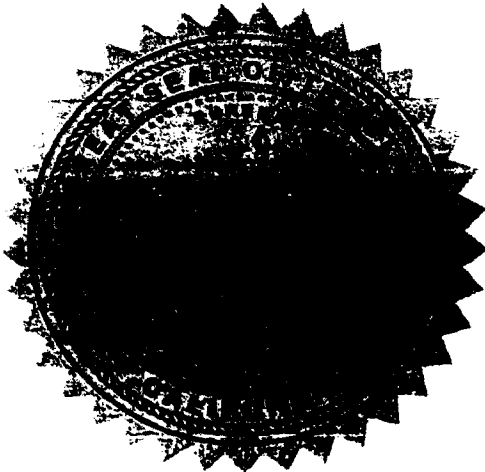

**NAME**


The name of the corporation is DuPont Displays, Inc."
