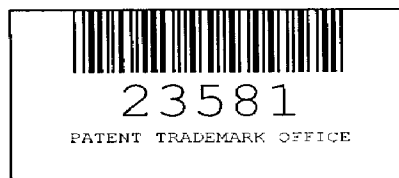

ASSIGNMENT

WHEREAS, we, Sergio Landau of Laguna Niguel, county of Orange, state of California, Dan Williamson of Sherwood, county of Washington, state of Oregon, and John R. Marshall of Beaverton, county of Washington, state of Oregon, have invented certain improvements in NEEDLE-FREE INJECTION SYSTEM, for which a patent application was filed on June 4, 2002 and given U.S. Application No. 10/164,920; and

Further, we hereby covenant and agree to and with Bioject Inc., and its successors and assigns, at the time of execution and delivery of these presents, that we are the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified

provisional patent application, and that the same are unencumbered, and that we have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, we agree that we will communicate to Bioject Inc., or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Bioject Inc., make all rightful oaths, and generally do everything possible to aid Bioject Inc., and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
