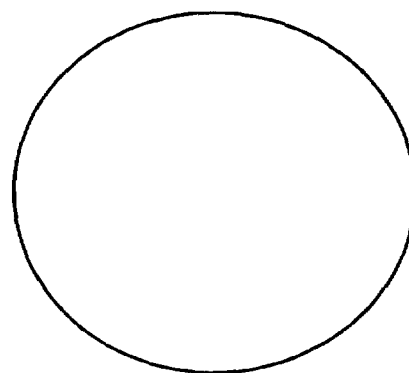


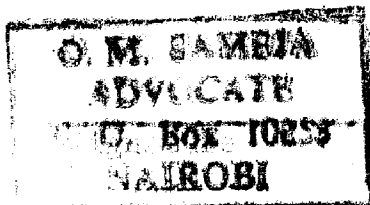
I REVOKE all my former Wills and other testamentary depositions made by me at any time hereto before and declare this to be my last Will.


