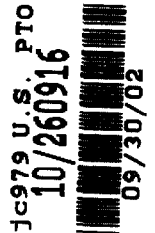


ASSIGNMENT OF INVENTION
