ASSIGNMENT

WHEREAS, I, **Winnie Wong**, a citizen of USA, a resident of 2603 Vanderbilt Lane, #3, Redondo Beach, California 90278, have invented certain new and useful improvements in **DISPLAY METHOD AND APPARATUS FOR NAVIGATION SYSTEM**, the application of which for a letter of patent was filed with the United States Patent and Trademark Office on June 19, 2002 with the assigned application No. 10/174,787;

AND I HEREBY covenant and agree that I will communicate to the said ASSIGNEE, his successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, his successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
