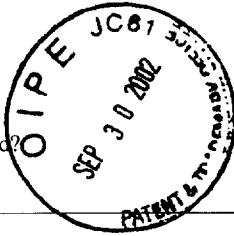

ASSIGNMENT

WHEREAS, We, **James W. Frame**, a citizen of the United States of America, a resident of 667 Park Avenue West #2, Highland Park, Illinois 60035, and **Richard W. Chrusciel**, a citizen of the United States of America, a resident of 35 Vincent Avenue, Belmont, Massachusetts 02478, have invented certain new and useful improvements in **COMPARATOR CIRCUIT FOR SEMICONDUCTOR TEST SYSTEM**, for which We filed an application for Letters Patent in the United States Patent and Trademark Office on May 1, 2002 with the assigned application number 10/136,506;

AND WE HEREBY covenant and agree that We will communicate to the said ASSIGNEE, his successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, his successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
