
ASSIGNMENT



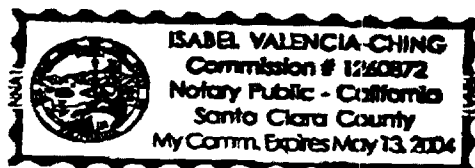
