AND FURTHER, Assignor hereby agrees that, when requested to carry out in good faith the intent and purpose of this Assignment, at the expense of said Assignee, but without charge to Assignee, its successors, assigns and legal representatives, Assignor will execute all continuations, divisions, substitutes, reissues, and extensions of said patent, execute all rightful oaths, assignments, powers of attorney and other papers, testify in any legal or quasi legal proceedings; communicate to said Assignee, its successors, assigns, and legal representatives all facts known to the undersigned relating to said invention and the history thereof; and generally do everything possible which said Assignee, its successors, assigns or legal representatives shall consider desirable for aiding in securing, maintaining and enforcing proper patent protection for the inventions and for vesting title to the inventions and all applications for patents on the inventions in said Assignee, its successors, assigns and legal representatives;

AND FURTHER, Assignor hereby covenants with Assignee, its successors, assigns and legal representatives that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by the undersigned, and that full right to convey the same as herein expressed is possessed by the Assignor.


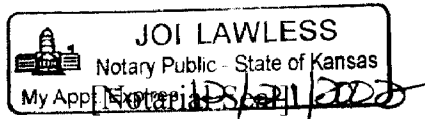
