ASSIGNMENT

Whereas, we, **Robert Murdock** and **Madison Kepler Mount**, have jointly invented a certain new and original design in a “**NAVIGATIONAL SYSTEM DISPLAY FOR A MOTOR VEHICLE**”, for which we submitted a U.S. Design Patent Application concurrently herewith (Porter, Wright, Morris & Arthur Docket No. 3996902-138805);

Now, therefore, for good and valuable consideration, the receipt of which is hereby acknowledged, we, **Robert Murdock** and **Madison Kepler Mount**, do hereby sell, assign and transfer to **COATO workshop Inc.**, the entire right, title and interest, in and to our invention of a new and original design in and to a “**NAVIGATIONAL SYSTEM DISPLAY FOR A MOTOR VEHICLE**”, said application for design patent, the invention therein described, and all rights appurtenant thereto and in all our applications related thereto, including each of the following: the right to apply for any design patent for said invention in the United States of America and in any and all other nations, any and all other applications for design patent on said invention including all divisional, renewal, substitute and continuation applications based in whole or in part upon said invention or upon said application or related thereto; any and all design patents that may issue thereon in the United States and other Nations and any and all reissues, extensions, renewals, divisions, or continuations of design patents granted for said inventions or upon said applications, to the full end of the term or terms for which said design patent may be issued; and every priority or other right accorded by every international convention, treaty or agreement that is or may be predicated upon or arise from said invention, application and other applications or design patent therefor, all to be held and enjoyed by **COATO workshop Inc.**, its successors and assigns, all the same as we would have held and enjoyed had this Assignment not been made.

We hereby authorize and grant the right to **COATO workshop Inc.**, to file and prosecute design patent applications in any or all countries on all or any part of said invention in our names or in the name of **COATO workshop Inc.**, or otherwise, as **COATO workshop Inc.** may deem advisable under any international convention, treaty, or agreement or otherwise.

We hereby request and authorize the Commissioner of Patents and Trademarks of the United States and the empowered officials of all other countries to grant, issue and


transfer any design patent for said invention to **COATO workshop Inc.** as assignee of the entire right, title and interests therein, in accordance with this instrument of assignment.

We hereby represent and warrant that there are no outstanding rights or interest inconsistent with the rights and interests granted herein; we covenant that we will not execute, grant, or transfer any rights or interests inconsistent herewith, we bind ourselves, our heirs, executors, administrators and legal representatives to execute and deliver to **COATO workshop Inc.**, its successors and assigns, any further documents or instruments and to perform any and all acts that may be deemed necessary to enable it, its successors and assigns, to file patent applications for design patent for said invention in any country in which it may elect to file such application, and to vest in **COATO workshop Inc.**, its successors and assigns, the title herein conveyed and intended to so be, and to enable such title to be recorded in the United States and each Nation in which each such application may be filed so that any patent issued thereon shall be issued to **COATO workshop Inc.**, its successors and assigns; and we further covenant and agree, for ourselves and our executors, administrators and legal representatives, that we and they will, upon request, communicate to **COATO workshop Inc.**, its successors and assigns, any facts relating to said invention and the history thereof, known to us or them and that we and they will testify as to the same in any proceeding, interference or litigation when requested to do so by **COATO workshop Inc.**, its successors and assigns.


