ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, I, Yeming Gu, of Suwanee, GA, have invented certain new and useful improvements in METHODS AND APPARATUS FOR OBTAINING IMAGING INFORMATION IN BAR CODE SCANNERS, Docket No. 10408, for which I have executed an application for Letters Patent of the United States on same date herewith, respectively; and

WHEREAS, NCR Corporation, a corporation of the State of Maryland, having its principal place of business in Dayton, Ohio, is desirous of acquiring the entire right, title and interest in and to said invention and in and to any Letters Patent that may be granted therefor in the United States and any and all foreign countries;

Further, I agree that I will communicate to said NCR Corporation, or its representatives, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said NCR Corporation, make all rightful oaths and generally to do everything possible to aid said NCR Corporation, its successors and assigns, to obtain and enforce protection for said invention in the United States and in any and all foreign countries.
