

ASSIGNMENT AND AGREEMENT

WHEREAS, Ramon Evangelista of 25266 Bentley Lane, Laguna Hills, CA 92653 and **Martha Garrity** of 151 Avenida Princesa, San Clemente, CA 92672; (hereinafter referred to singly and collectively as "ASSIGNOR") have invented a certain invention entitled **HYDROPHILIC CHEMILUMINESCENT ACRIDINIUM LABELING REAGENTS** (Atty. Dkt. No. 034827-1601) for which an application for United States Letters Patent was filed on August 20, 2002 as Application No. _____; and

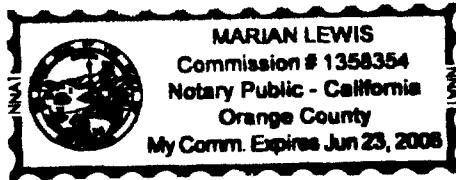
