ASSIGNMENT OF U.S. PATENT APPLICATION

WHEREAS, **Acer Inc.**, a Taiwanese company having a principal place of business at 21F, 88, Sec. 1, Hsin Tai Wu Road, Hsichih, Taipei Hsien 221, Taiwan, Republic of China (hereinafter "**ASSIGNOR**"), is the owner by assignment recorded at Reel 011561, Frame 0781, of U.S. Patent Application No. **09/791,066**, filed on February 22, 2001, for **Base Capable of Adjusting the Elevation of a Panel**, and the improvements therein;


NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, **ASSIGNOR** hereby acknowledges that it has sold, assigned, transferred and conveyed, and by these presents does hereby sell, assign, transfer and convey, unto **Wistron Corporation** and **Acer Inc.**, their successors, legal representatives, and assigns, the entire right, title, and interest throughout the world in, to, and under the Patent Application and all Patents that may be granted on the Patent Application, including all divisions, continuations, reissues, reexaminations, renewals, and extensions thereof, and all rights of priority under International Conventions and applications for Letters Patent that may hereafter be filed for the improvements therein or for patent applications having priority from the Patent Application in any country or countries foreign to the United States; and **ASSIGNOR** hereby authorizes and requests the Commissioner of Patents of the United States, and any Official of any country foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for the improvements and all Letters Patents resulting from the Patent Application or from any application having priority from the Patent Application to **Wistron Corporation** and **Acer Inc.**, their successors, legal representatives, and assigns, in accordance with the terms of this Assignment.

ASSIGNOR also acknowledges and confirms that it has sold, assigned, transferred and conveyed to **Wistron Corporation** and **Acer Inc.**, their successors, legal representatives, and assigns, all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to **Wistron Corporation** and **Acer Inc.**, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of any patents issuing from the Patent Application or issuing from any patent application having priority from the Patent Application.

ASSIGNOR hereby covenants and agrees that it will communicate to **Wistron Corporation** and **Acer Inc.**, their successors, legal representatives, and assigns, any facts known to **ASSIGNOR** respecting the Patents and Patent Applications immediately upon becoming aware of those facts, and that it will testify in any legal proceeding involving any of the Patents and Patent Applications, will sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths, and will generally do everything possible to aid **Wistron Corporation** and **Acer Inc.**, their successors, legal representatives, and assigns, to obtain and enforce the patents and any Letters Patents resulting from the Patent Applications in all countries.
