And I hereby agree to execute any papers presented to me by the said ASSIGNEE, its successors, assigns, and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred;


Agreeing furthermore, upon request of said ASSIGNEE, and without further remuneration, to transfer a like interest in and to any and all applications filed or patents granted for said invention or improvements, in countries other than the United States, and to execute any and all papers necessary to the filing and granting of foreign applications and for the perfecting of title in said ASSIGNEE;

Additionally agreeing, without any payment by ASSIGNEE, other than expenses incurred by me, to communicate to the ASSIGNEE, its representatives or agents, any facts relating to said invention or improvements, including evidence for interference purposes or for other legal proceedings, whenever requested; testify in any interference or other legal proceedings, whenever requested and execute and deliver, on request, all lawful papers required to make any of the foregoing provisions effective.

The undersigned hereby authorizes the U.S. attorney named in the Declaration of the application to which this assignment relates, or any associate or substitute thereof, to accept and follow instructions from ASSIGNEE as to any action to be taken in the U.S. Patent and Trademark Office regarding this application without direct communication between said attorney and the undersigned.
