all lawful papers, execute all divisional, reissue, and continuation applications, and generally do

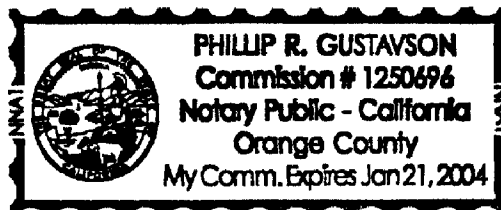

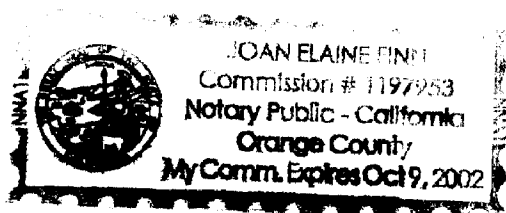
