ASSIGNMENT

WHEREAS, WE, **Christopher A. Kin**, a citizen of the United States, residing at 6389 Stapleton Court, Hamilton, OH 45011, and **Henry R. Kin**, a citizen of the United States, residing at 10599 Mill Road, Cincinnati, OH 45240 (hereinafter referred to as "ASSIGNORS"), have invented a Rug Display System, for which we have executed an application for Letters Patent of the United States, on even date herewith; and
