ASSIGNMENT

WHEREAS, I, Dieter Draxelmayr, of Villach, Austria, hereinafter ("Assignor"), have invented certain new and useful improvements in SENSOR APPARATUS AND METHOD FOR GENERATING AN OUTPUT SIGNAL OF A SENSOR APPARATUS for which application for a U.S. Letters Patent was made on July 26, 2002 as Application Serial No. 10/205,782 (based on German application no. 10004080.2 filed January 31, 2000).

Assignor hereby requests that said Letters Patent be issued in accordance with this assignment.

Assignor further covenants and agrees that, at the time of the execution and delivery of these presents, Assignor possesses full title to the invention and application above-mentioned, and that he has the unencumbered right and authority to make this assignment.

Assignor further covenants and agrees, and likewise binds his heirs, legal representatives and assigns, to promptly communicate to said Assignee or its representatives any facts known to them relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional




