AND, Weidenhammer Packungen KG GmbH & Co. further covenants and agrees, in consideration of the premises, that it, its executors and administrators will, at any time upon request, communicate to the said ABRO Weidenhammer GmbH, its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to it or its successors and assigns, and that it will testify as to the same in any interference or other proceeding when requested to do so by the said ABRO Weidenhammer GmbH, its successors and assigns.
