OFFSHORE SHUTTLE AS, organization number 977 097 517 was registered in the Register of Business Enterprises on 11 February 1997.

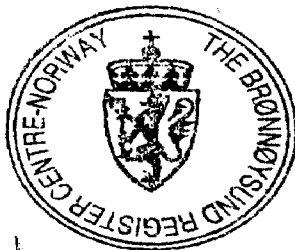
