## JOINT INVENTORS

WHEREAS, Frank Poma, residing at 1740 S.E. Clemont Street, Port St. Lucie, Florida 34984, and Albert T. Purino, residing at 18810 Misty Lake Drive, Jupiter, Florida 33458 (collectively referred to herein as "Inventors"), having invented certain new and useful improvements in **REINFORCED SHUTTER STRUCTURE** ("Invention"), for which a United States patent number 5,907,929 was issued on June 1, 1999, and a United States patent application was filed on May 28, 1999, Serial No. 09/322,553; and;
