ASSIGNMENT

WHEREAS, WE, GEOFF GOSLING and COLIN BLEHM, citizens of Canada residing at 32 Collingwood Place N.W., Calgary, Alberta, T2L 0P9, Canada and 286 Tuscan Valley View, Calgary, Alberta, T3L 2K8, Canada have invented certain new and useful improvements in a CONSOLE WITH POSITIONALLY INDEPENDENT UPPER AND LOWER HALVES (the invention) described and claimed in the Canadian patent application filed October 17, 2002 and the United States application for Letters Patent executed concurrently herewith (the "application");

AND WE HEREBY AUTHORIZE the Assignee to make applications for and to receive Letters Patent for said invention in any foreign countries in its own name or in any name at its election.



AND WE HEREBY AUTHORIZE AND REQUEST The Commissioner of Patents or the Comptroller (as the case may be) to issue any and all Letters Patent for said invention or resulting from said applications or from any division, reissue or extension thereof to the Assignee as sole Assignee.


