AND I, for myself, my heirs, assigns, and legal representatives, hereby covenant to and with said Assignee, its assigns, successors and legal representatives, that I have full right to sell and assign the entire interest in and to said invention and the Letters Patent to be had therefor and that the entire interest herein conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance whatsoever.

AND I do hereby authorize and request the Director of Patents and Trademarks to issue said Letters Patent to said Floratech Industries, Inc. as the assignee of our entire right, interest, and title therein.


