ASSIGNMENT OF PATENT RIGHTS

SMITHKLINE BEECHAM CORPORATION, doing business as GLAXOSMITHKLINE, a Pennsylvania corporation ("*Assignor*"), hereby assigns certain patent rights to AFFINIUM PHARMACEUTICALS, INC., a Canadian corporation ("*Assignee*").

NOW THIS ASSIGNMENT WITNESSETH that, for the consideration provided for in, and pursuant to that certain Asset Sale and Purchase and Licensing Agreement by and between the Assignor and the Assignee dated December 18th, 2002 (the "*Agreement*"), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, as beneficial owner, hereby assigns and transfers to Assignee Assignor's whole right, title and interest throughout the world in and to the Patents, said invention or inventions and any and all other patents and patent applications in the United States of America or any foreign country which may be filed or granted therefor and thereon (including, without limitation, all divisional, continuation, continuation-in-part or substitute patent applications which may be filed upon said invention or inventions or which claim priority to any of the Patents, and any patents in the United States of America or any foreign country granted therefor and thereon), and in and to any and all reissues or extensions of the Patents or of such other patents, and in and to any application filed in any foreign country based thereon (including, without limitation, the right to file said foreign applications and claim priority under the provisions of any international convention or treaty), and the full exclusive benefits thereof, and all rights, privileges and advantages appertaining thereto, including any and all rights to damages, profits or recoveries of any nature for past infringement of any of the foregoing patents and patent applications, and the payment of any and all maintenance fees, taxes, and the like, to hold the same unto and to the use of Assignee, its successors and assigns absolutely during the residue of the respective terms for which the Patents and such other patents were granted and during any such terms. Assignor hereby authorizes and requests the appropriate governmental authority of the United States of America or any foreign country to issue all patents resulting from any of the foregoing patent applications or patents to the Assignee, as the assignee of the entire interest therein. Assignor hereby covenants that Assignor has not executed and will not execute any agreements inconsistent with this Assignment.
