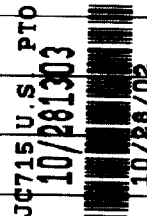


WHEREAS, BPOWER INC.
