WHEREAS, Yi Zhang, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled CALLING CARD SYSTEM FOR VOICE AND DATA TRANSMISSION OVER A PUBLIC NETWORK, executed by Assignor on the same date as this Assignment;

WHEREAS, SBC PROPERTIES, L.P., a partnership organized and existing under the laws of the State of Nevada, having a place of business at 645 E. Plumb Lane, Reno, Nevada, 89502, hereinafter called the "Assignee", desires to acquire the entire right, title and interest in and to the invention and the patent application identified above, and all patents which may be obtained for said invention, as set forth below;

The Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and in the prosecution of any interference which may arise involving said invention, or
