ASSIGNMENT

WHEREAS, I, Thomas M. Leathers of Granger, IN have made certain inventions which are described in an application for Letters Patent of the United States entitled "Aircraft Ground Support Air Conditioning Unit With Heat Exchanger Bypass"; and

I further grant to said Company, its successors and assigns, the right to claim for any of said applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries or between any other countries.

I HEREBY warrant that I have the full right to make the conveyance herein, and I thereby covenant and agree to and with said Company, its successors, legal representatives and assigns, that I will, whenever counsel of said Company or the counsel of its successors, legal representatives and assigns, shall advise that any proceeding in connection with said inventions, or said application for Letters Patent, or any country, including interference proceedings, is lawful and desirable, or that any division, continuation or continuation-in-part of any application for Letters Patent, or any reissue or extension of any Letters Patent, to be obtained thereon, is lawful and desirable, sign all papers and documents, take all lawful oaths, testify in any legal proceedings, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent for said inventions, with compensation to and without charge to ourselves, our successors, legal representatives and assigns, but at the cost and expense of the Company, its successors, legal representatives and assigns.
