**ASSIGNMENT**

WHEREAS, We, Davide Rizzo, a resident of San Diego, San Diego County, California, and citizen of Italy, and Osvaldo Colavin, a resident of San Diego, San Diego County, California, and a citizen of France, have invented certain new and useful improvements in "METHOD AND APPARATUS TO ADAPT THE CLOCK RATE OF A PROGRAMMABLE COPROCESSOR FOR OPTIMAL PERFORMANCE AND POWER DISSIPATION" disclosed in an application for United States Letters Patent (Application No. \_\_\_\_\_, filed \_\_\_\_\_, said application having been executed concurrently herewith;
