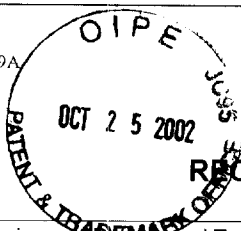

## **ASSIGNMENT**

**WHEREAS, WE, CARLY WHITE**, having an address at 30 Pitcher Avenue, Medford, MA 02155; **CHRISTOPHER REINKE**, having an address at 6 Kristopher Lane, Townsend, MA 01474, and **CHARLES W. SEARS**, having an address at 39 Joseph Smith Way, Boxford, MA 01921, (**ASSIGNORS**), have invented certain new and useful improvements in a **CONTAINER FOR MOIST WIPES**, for which an application for Letters Patent was filed in the U. S. Patent and Trademark Office on May 28, 2002, and accorded U. S. Design Application No. 29/161,194;

**ASSIGNORS** hereby authorize and request the patent office officials in the United States and in all foreign countries to issue all of said Letters Patent to **FORT JAMES CORPORATION** as the owner of the entire right, title and interest in and to the same.

ASSIGNORS further agree to communicate to FORT JAMES CORPORATION any facts known to ASSIGNORS respecting said invention, and to testify in any legal proceeding, to sign all lawful papers, to execute all divisional, continuation, continuation-in-part, substitution, renewal, reexamination, and reissue applications, to execute all assignment papers to cause all of said Letters Patent to be issued to FORT JAMES CORPORATION, to make all rightful oaths and generally do everything possible to aid FORT JAMES CORPORATION, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in all foreign countries.

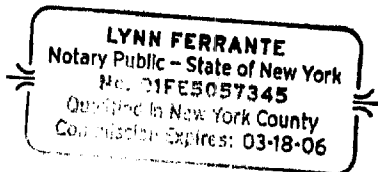




