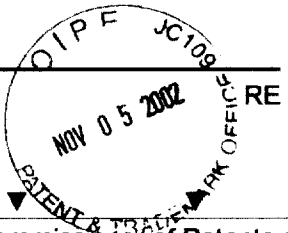

1. They are the President and the Secretary, respectively, of CreOsys Inc., a California Corporation (the "Corporation").
2. Article I of the Articles of Incorporation of this Corporation is hereby amended to read in full as follows:


"I.

The name of this Corporation is ORIDUS INC."

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporation Code. The total number of outstanding shares of this Corporation is 2,380,000 shares of Common Stock and 12,715,000 shares of Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%) of the outstanding shares of Common Stock and more than fifty percent (50%) of Preferred Stock, voting as separate classes.

The undersigned declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of their own knowledge.

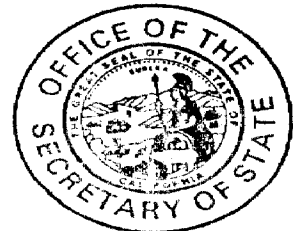
