

WHEREAS, American Medical Systems Inc., 10700 Bren Road West, Minnetonka, MN 55343 (hereinafter referred to as **ASSIGNOR**), owns a right, title and interest to inventions and improvements embodied in U.S. Pat. ASSIGNOR covenants to promptly execute and deliver to **ASSIGNEE** or its legal representatives any and all papers, instruments, documents or affidavits required to apply for, obtain, maintain, and issue said **PATENT RIGHTS**, and said reissues, reexaminations, improvements, continuations and divisions thereof in any foreign country which may be necessary or desirable.




