

**A CARGO COMPARTMENT FOR A LIGHTER-THAN-AIR VEHICLE**

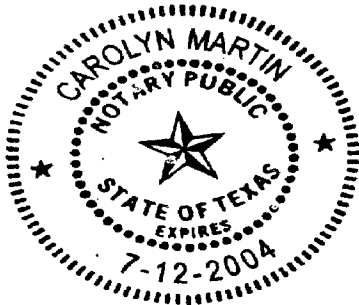
