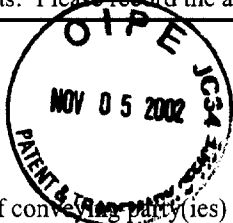

ASSIGNMENT

WHEREAS, I, Masataka Tsunoda, citizen of Japan, have invented certain new, original, and ornamental designs:

PISTONS FOR REFRIGERANT COMPRESSORS

described in an application for United States Letters Patent filed on September 14, 2000 and accorded Application No. 29/129,342;

AND I hereby agree for myself and my heirs, executors and administrators to execute without further consideration any further documents and instruments which may be necessary, lawful and proper in the prosecution of said above-referenced application or in the preparation or prosecution of any continuing, substitute, divisional, renewal, reexamination or reissue application or in any amendments, extensions or interference proceedings, that may be necessary to secure to ASSIGNEE its interest and title in and to said designs or any parts thereof, and in and to said several patents or any of them;

AND I hereby covenant for myself and my legal representatives, and agree with said ASSIGNEE, its successors and assigns, that I have granted no right or license to make, use or sell said designs, to anyone except said ASSIGNEE, that prior to the execution of this deed, my right, title and interest in said designs had not been otherwise encumbered, and that I have not and will not execute any instrument in conflict therewith;

AND I do hereby authorize and request the Director of the United States Patent and Trademark Office to issue any and all letters patent which may be granted upon said United States patent applications, or upon said designs or any parts thereof when granted, to said ASSIGNEE.
