Assignment

THIS ASSIGNMENT is made on 28th day of October, 2022

BETWEEN :-

- (1) **PROFIT BEYOND ASSETS LIMITED**, a company incorporated and registered in the British Virgin Islands whose registered office is at P.O. Box 957, Offshore Incorporations Centre, Road Town, Tortola, British Virgin Islands (the “**Assignor**”); and

- (2) the entire right, title and interest in and to any and all patents or reissues or extensions thereof to be obtained in U.S. or any foreign country upon said invention or inventions and
- (3) any divisional, continuation, continuation-in-part or substitute applications which may be filed upon said invention or inventions in U.S. or any foreign country; and
- (4) any and all national patent applications that correspond in whole or in part to the continuations-in-part or substitute applications which may be filed upon said invention or inventions in the U.S. or any foreign country; together with
- (5) authority to issue any and all patents on said application or applications to said assignee or its successors; as well as
- (6) the right to sue and recover all claims for damages for all infringements, for its own use and for the use of its successors, assigns and legal representatives.

The Assignor warrants that it is the sole legal and beneficial owner of the said invention and the Application and no license, assignment or legal or equitable charge has been granted or made in respect of any of them.

The Assignor undertakes to execute sign and do all such documents acts and things and render such assistance as the Assignee may require to secure the vesting in the Assignee of all rights in the said invention and the Application and to enable the Assignee to enjoy the full benefit of the property and rights hereby assigned.

The Assignor shall have no further obligation to prosecute, market or license the application(s). The Assignor shall have no liability for the application or the inventions embodied therein or for Assignee's use or disposition of such invention(s). Assignee agrees to defend, indemnify, and hold harmless Assignor from any loss, claim, damage, or liability, of any kind whatsoever, which may arise from Assignee's use or disposition of the invention(s).

Neither party shall use the name, trade name, trademark or other designation of the other party in connection with any products, promotion or advertising without the prior written permission of the other party.

The validity, construction and performance of this Agreement shall be governed by the laws of HKSAR and shall be subject to the non-exclusive jurisdiction of the courts of HKSAR which the parties hereby submit, except that a Party may seek an interim injunction in any court of competent jurisdiction.


