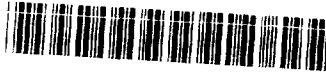

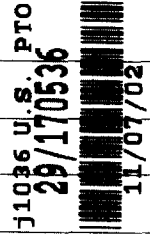

## ASSIGNMENT

WHEREAS, Boyd Willat, of Los Angeles, California, Paul Bob Velick of Santa Monica, California, Robert Portillo, of Carlsbad, California and Jeffrey M. 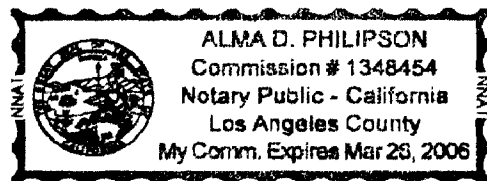

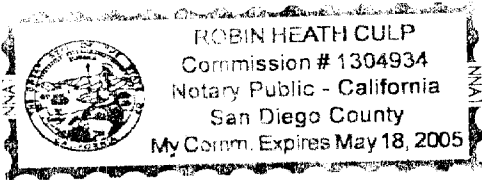

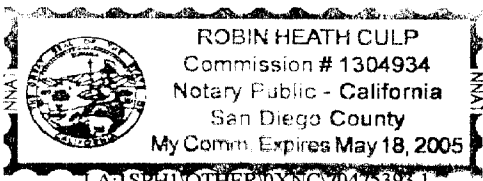
