It is hereby Stipulated by and between Claudia M. Bringe and Daren J. Luedtke as follows:

1. Daren J. Luedtke acknowledges owing child support arrears in the amount of \$11,519.59 and agrees to pay the same in a lump sum immediately.

2. Daren J. Luedtke acknowledges owing interest on his child support arrears in the amount of \$0,545.00 and agrees to pay the same by means of monthly payments of \$000.00 per month with full payment to be completed not later than September 30, 2003.
