- (2) KALDAIR HOLDINGS INC whose address is at Kaldair House, Langley Quay, Waterside Drive, Langley, Berkshire SL3 6EY

INTRODUCTION

- (A) BP is the registered proprietor of the various patents listed in Schedule 1 in the various countries also indicated in Schedule 1.
- (B) BP has agreed to assign the Patents to Kaldair.

IT IS AGREED THAT:

1 DEFINITIONS

1.1 The following words which begin with capital letters in this agreement have the precise meanings set out below.

- 1.1.1 "Kaldair" means Kaldair Holdings Inc.
- 1.1.2 "the Patents" means the various patents listed in Schedule 1.
- 1.1.3 "BP" means B P Amoco p.l.c (formerly The British Petroleum Company Plc (formerly The British Petroleum Company Limited))

2 AGREED TERMS

2.1 BP with full title guarantee assigns to Kaldair absolutely the Patents, together with all rights of action, powers and benefits belonging or accrued to the same (including the right to sue for and recover damages for past infringements).

2.2 BP shall at the request and cost (as to out of pocket expenses only) of Kaldair:

2.2.1 from time to time as requested by Kaldair execute such further assurances and documents and afford to Kaldair such assistance as Kaldair may reasonably require for the purpose of vesting in Kaldair (or its nominee) the full benefit of the Patents;

2.2.2 assist Kaldair in the prosecution of any required application to register or otherwise record this assignment.

2.3 BP warrants that:

2.3.1 it has not previously assigned the Patents to any other person;

2.3.2 it is fully entitled and able to make the assignment contained in this agreement;

2.3.3 the Patents:

2.3.3.1 are not subject to any charges, mortgages, liens or encumbrances other than with respect to official fees payable to national patent offices; and

2.3.3.2 are not subject to any licences or other agreements affecting the same or restricting their use by Kaldair in any way, other than as set out in any licences set out in Appendix M of the agreement between BP International Limited, BP America Inc, Kaldair Holdings Limited and Kaldair Holdings Inc dated 31 January 1997 for the sale and purchase of the issued share capital of Kaldair Limited and Kaldair Incorporated.

2.4 It is hereby certified that this assignment falls into category L of the Stamp Duty (Exempt Instruments) Regulations 1987.
