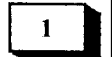

## ASSIGNMENT


WHEREAS, We, GARRY MARTY, GERALD McNERNEY and SCOTT JONES, have invented a new original and ornamental design for a WRENCH for which we have made application for Letters Patent of the United States of America; and




