## **ASSIGNMENT**

I hereby authorize the Assignee to file patent applications in any and all countries on said design in my name, or in its name, or otherwise as the Assignee may deem advisable, under the International Convention or the applicable laws of a particular jurisdiction.

By this Assignment, I have hereby sold, transferred and set over and by these presents hereby sell, assign, transfer and set over to the Assignee all interest in copyright in and to said design, including the right to register said copyright as assignee thereof. I hereby waive my rights of attribution and integrity under 17 USC § 106A with respect to said design, for any and all uses thereof.


