GONCALVES AND TERRY FAYE do hereby sell, assign, transfer, and convey unto SPECTRA PRODUCTS INC., its successors and assigns, all of their right, title and interest in and to the said invention, any application for Letters Patent in any country to be filed, and any Letters Patent for the invention that may be granted and in any re-issue or extension thereof and in any improvements in the invention now existing or hereinafter arising in Canada, the United States of America, the same to be held and enjoyed by SPECTRA PRODUCTS INC. as it would have been held and enjoyed by the said JORGE M. GONCALVES AND TERRY FAYE had the sale, assignment, transfer, and conveyance not been made.

THE said JORGE M. GONCALVES AND TERRY FAYE hereby further agree, undertake and covenant that they will sign or execute such further documents, assurances, applications, instruments or any other writing that may be requested by SPECTRA PRODUCTS INC. or its legal representatives for the purpose of obtaining or issuing any Letters Patent for the said invention or any re-issue or extensions thereof, or any improvements therein in order that all of their right, title and interest in the same may be vested in SPECTRA PRODUCTS INC., its successors and assigns.
