## ASSIGNMENT

**WHEREAS**, the undersigned, Alistair Zorica, an Australian citizen residing in Australia, referred to hereinafter as "ASSIGNOR", has invented a certain invention entitled "MINIMAL SEAMED FITTED GARMENT" for which an Australian provisional application numbered PS2796 was filed, and for which a PCT application was filed on or about September 5, 2002 (jointly hereinafter "APPLICATIONS"), the invention together with related experimental data, trade secret, and other know-how being referred to hereinafter as the "INVENTION".

**WHEREAS**, Watermoons Pty Ltd. (ACN 087 379 619), an Australian Proprietary Company having its principal place of business at Quiksilver Dr., Torquay, VIC 3228, Australia, referred to hereinafter as "ASSIGNEE", is desirous of acquiring the entire right, title and interest in, to and under said INVENTION, the entire right, title and interest in, to and under said invention being referred to hereinafter as the "RIGHTS".

**WHEREAS**, the RIGHTS include but are not necessarily limited to any rights conferred by or derivable from:

- (a) the APPLICATIONS;
- (b) any Letters Patent, utility models, inventor's certificates, or similar legal protection to be, or having been, obtained from, claiming priority to, or otherwise benefiting from the APPLICATIONS and any continuation, continuation-in-part, divisional, renewal, substitute, reissue or reexamination thereof;
- (c) any other Letters Patent utility models, inventor's certificates, or similar legal protection to be, or having been, obtained for said INVENTION in any and all countries throughout the world and their territorial possessions, said countries including but not being limited to Australia, the United States of America, and any other countries designated in the above referenced PCT application.

**WHEREAS**, Ug Manufacturing Co Pty Ltd., an Australian Proprietary Company having its principal place of business at Quiksilver Dr., Torquay, VIC 3228, Australia, referred to hereinafter as "PRIOR ASSIGNEE", has previously assigned any of the RIGHTS it had to ASSIGNEE.

**WHEREAS**, ASSIGNOR is an employee of PRIOR ASSIGNEE and may have, by virtue of his employment or prior agreement with PRIOR ASSIGNEE, assigned all or some of the RIGHTS to PRIOR ASSIGNEE prior to the assignment of any RIGHTS from PRIOR ASSIGNEE to ASSIGNEE.


**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby sells, assigns, transfers and sets over unto the ASSIGNEE, its successors and assigns any of the RIGHTS not previously assigned to ASSIGNEE or PRIOR ASSIGNEE by ASSIGNOR, said RIGHTS to be held and enjoyed by the ASSIGNEE for its own use and benefit, and for the use and benefit of its successors or assigns, to the full end of the term for which said RIGHTS may be granted, as fully and entirely as the

same would have been held and enjoyed by ASSIGNOR if this assignment and sale had not been made.


ASSIGNOR further covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.
