And I further covenant and agree that I will, at the request and expense of the said Assignee, execute such further assurance of title as may be necessary or proper to fully convey the interest herein sought to be conveyed; that I will, at the request and expense of the said Assignee, execute such application papers as may be desired by the said Assignee for the filing of any division, continuation, renewal, or continuation-in-part of the application herein conveyed, or for the reissues or extension of any Letters Patent that may be granted upon said application, and will execute such Supplemental Oaths and Preliminary Statements, or other papers as desired by the said Assignee.

And I further assign unto the said Assignee my whole right, title, and interest to the invention disclosed in the application throughout all countries foreign to the United States, and do hereby authorize the said Assignee to apply for patents therefor in its own name in countries where such procedure is proper and to claim the benefit of the International Convention and I do agree to execute applications for the said invention in the several countries where it is necessary that the same be executed by the inventor, and to execute assignments of such applications and the patents to be obtained therefor to the said Assignee, as well as all other necessary papers.
