ASSIGNMENT



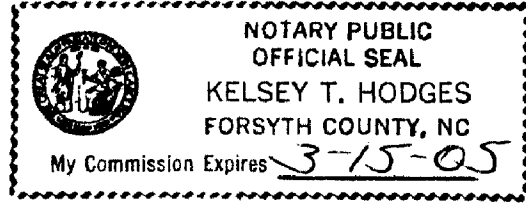
