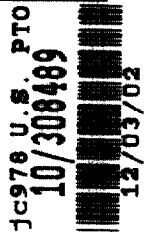

WHEREAS, I, Daryoush Allaei, residing at 3223 Fairchild Avenue, Minnetonka, Minnesota 55391, made certain new and useful inventions and improvements for which I executed an application for Letters Patent of the United States filed herewith, which is entitled **ACOUSTICALLY INTELLIGENT WINDOWS** (the "Application").

AND, for the consideration identified above, I do agree that me and my executors and legal representatives will make, execute and deliver any and all other instruments in writing including any and all further application papers, affidavits, assignments and other documents, and will communicate to the Assignee, its successors and representatives all facts known to us relating to the improvements and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable more effectually to secure to and vest in the Assignee, its successors or assigns the entire right, title and interest in and to the improvements, inventions, applications, Letters Patent, rights, titles, benefits, privileges and advantages hereby sold, assigned and conveyed, or intended so to be.

AND, furthermore I covenant and agree with the Assignee, its successors and assigns, that no
