ROUND BASKET


for which I am about to make application for Design Letters Patent of the United States; and

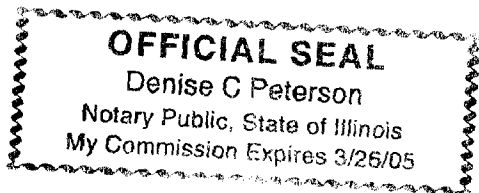
