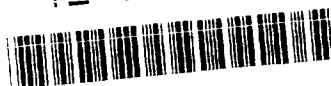

ASSIGNMENT OF UNITED STATES PATENT APPLICATION


WHEREAS, we, Douglas P. Brown, Delynn Anne Kelly and Diana Lynn Thomas, of Rancho Santa Fe, California, Poway, California and Vista, California, respectively, have invented certain new and useful improvements in **SYSTEM AND METHOD FOR LOGGING DATABASE QUERIES**, Docket No. NCR 10903, for which we have executed an application for Letters Patent of the United States on same date herewith, respectively; and




