

## PERFORMANCE DRILLING WYOMING (BY SHAREHOLDERS)

PERFORMANCE DRILLING WYOMING, a Wyoming corporation, hereby adopts the following Article of Amendment as follows:

## ARTICLE I

The name of the corporation shall be HUNTING PERFORMANCE, INC...

- 1. The amendment was adopted on May 7, 2002 by the shareholders of the corporation.
