agreement affecting the fights and property herein conveyed has been made to others by me, and that full right to convey the same as herein express is possessed by me.

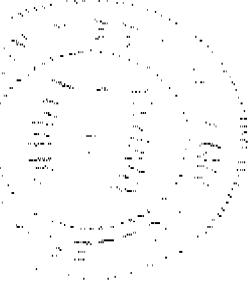
